# **2024 ANNUAL REPORT**



By no stretch of the imagination is it an overstatement to say that 2024 was an extraordinary year for Chamber San Mateo County. With an increased focus on policy, communication and member engagement efforts, the Chamber elevated its operations to support the second year of its expanded footprint that now encompasses 1,500 members, 175,000 residents and 100,000 employees in Redwood City, San Carlos, Menlo Park and Belmont and throughout San Mateo County.

In 2024, Chamber San Mateo County was front and center in advocacy efforts for transportation and housing efforts, and played pivotal roles in shaping tax measures in Redwood City and Belmont to protect businesses and support those communities. This was complemented with efforts to bring greater awareness to Chamber members about candidates running for office and underscoring the importance of exercising the collective voice of the business community for responsible community growth, fair economic conditions and good and responsive government.

In all, 2024 can go in the Chamber's annals as a consequential year of action and results!

### **City of Redwood City Business License Tax**

The Chamber, through its Board and staff, spent several months working to shape the outcome of the Redwood City business license tax update. In April 2024, Redwood City Council coalesced around a gross receipts tax proposal. The Chamber worked closely with the elected officials and staff to ensure that the voices of businesses were heard and the impact of such a policy was understood. In addition to broad concerns about harmful impacts of gross receipts models in general, the Chamber also drew attention to the lack of business engagement and flawed data the City was using to reach its decision. As a result of months of advocacy by the Chamber and its Redwood City members, including nearly a dozen focus group meetings with nearly 100 businesses, along with countless calls, emails and letters, Council abandoned its consideration of a gross receipts tax model. **This shift by** 

#### Council was a massive win for Chamber members!

Redwood City then went about revising its current per-employee business license tax model and increasing the cap for overall tax liabilities for businesses. Again, the Chamber went about working to refine the many iterations of the proposal that eventually made its way to Council on June 22, 2024. We argued that both the fee for certain categories (especially professional services) and the cap of \$500,000 were unreasonable and unacceptable. In particular, we reinforced that the proposal would hurt businesses, put workers at risk, and would cause a cascading effect that could impact small businesses, school districts and future economic growth in the city.

Though we were not successful in lowering the fees, through our advocacy and through the voice of our members, we were able to convince enough members of Council of the harm in rate of the cap. Council amended the proposal to lower the cap by half to \$250,000. **This was also a big win for the Chamber members!** 

### **City of Belmont Business License Tax**

In Belmont, unlike in Redwood City, staff engaged the Chamber from the very beginning of their discussions about a transition to a gross receipts model. We, again, made our position clear in opposing the model. Through a hand-in-glove partnership with Belmont staff, the Chamber worked to engage Belmont businesses in discussions to understand impacts of a new taxing model. A key difference between the Belmont and Redwood City proposals was that Belmont's proposal was revenue-neutral, with the City attempting to modernize its taxing structure to be more equitable, while not attempting to gain any new revenue for the city. While the Chamber did not agree with the taxing model, we worked to mitigate the risk to and impact on businesses and reinforced the need for containment through Belmont's revenue-neutral approach.

In July 2024, the Belmont Council approved language for a ballot measure to send a gross receipts tax model to the voters of the city on the November 2024 ballot. **Chamber San Mateo County continues to oppose this measure.** 

### **Programs and Events Updates**



Nearly 300 leaders from all sectors in San Mateo County convened for the 55th annual Progress Seminar in Sonoma County on April 19 – 21, 2024. **BIG KUDOS to Progress Seminar co-chairs: Rosanne Foust, Julie Lind, Mike Callagy and Dr. Jamillah Moore!** 

This year's sessions and speakers provided masterclasses on topics that are impacting our community, including: strengthening democracy, philanthropy, healthcare, federal funding, artificial intelligence, and the need for strong transit systems.

The Chamber Leadership program graduated its 36th class of 56 participants on June 7, 2024, with representatives from all spectrums of the business, government, not-for-profit and education sectors. Congressman Kevin Mullin provided the keynote address at the graduation ceremony. Throughout the program, participants engaged in sessions:

- Focusing on diversity, equity, and inclusion as it relates to education, business & economic development, healthcare, public safety, housing, and transportation;
- Highlighting climate resilience and sustainability initiatives such as clean energy, wildfire mitigation, and sea-level rise;
- · Discussions surrounding mental health in both professional and personal realms; and
- Promoting civic engagement and community involvement through public office, Boards, commissions, and volunteer opportunities.

The 2024-2025 Leadership class is sold out and the program begun on September 13, 2024.



In 2022, we made the decision to revamp our traditional "mixers" and introduced them as engaging "Off the Clock" networking events. Since 2022, the Chamber has hosted 21 "Off the Clock" events, attended by 838 participants.



The Chamber presented their 126th annual leadership awards on February 29, 2024, at a luncheon event that celebrated an all-female slate of honorees.



# **Board Retreat and Strategy Development**

Chamber San Mateo County's Board of Directors met for their annual retreat on January 25, 2024. Due to the impacts of the COVID-19 global pandemic, this was the first board retreat since January 2020.

The purpose of the retreat was to identify priority areas of focus that will populate the Chamber's annual program of work. To inform the planning process, various stakeholder groups (Board members, city officials, Chamber members) were engaged – through online surveys – to gather feedback about Chamber services and programs, and to better understand their perceptions, perspectives and needs.

The Board established four priority areas of focus:









To implement these areas of focus, the Board also directed follow-up on three priority areas:

- Communication
- Government Relations
- Being more assertive in shaping the political landscape

### **Communications Plan**

Launched from the Board retreat, the Chamber CEO hired MBailey Advisors to develop and assist with implementing a communications plan. The plan consists of four goals and four strategies:

#### Goals

- Move from simply communicating to fully engaging.
- Generate support and enthusiasm for Chamber members and the services they provide.
- Influence decisions and decision-makers.
- Enhance the profile of the Chamber and reinforce its value proposition.

#### **Strategies**

- Tell the stories of Chamber members
- Tell the Chamber's story
- Inform, educate and persuade elected officials and their staffs
- Elevate the Chamber's influence

To achieve these goals, the Chamber has:

- Published its re-designed Annual Report
- Published weekly newsletters
- Launched a Member Spotlight series, which, to date, has highlighted 15 members in the Chamber's weekly newsletter
- Redesigned the Chamber website
- Published a monthly CEO letter to members
- Authored an op-ed on "Businesses are paying their fair share"
- Provided special alerts and notices regarding timely local policy issues

### **Government Relations Plan**

Also launched from the Board retreat, the Chamber CEO hired MBailey Advisors to also develop and assist with implementing a government relations plan. The plan consists of four goals and six strategies:

#### Goals

- Know, understand and have productive relationships with elected officials and city staffs in the Chamber's service area
- Inform and influence decisions
- Identify and cultivate talent for elected and appointed office
- Create an ecosystem where the Chamber is an elected-official's go-to on business and big community issues

### **Strategies**

- Be present, visible, vocal and helpful
- Keep members informed and mobilize as needed
- Encourage identified talent to seek elected and appointed positions (including planning commissions, arts commissions, etc.)
- Keep officials informed and engaged (let them know who they represent and who we represent)
- Engage the Board in fostering and maintaining relationships and exerting influence
- Show up and show out preparation, professionalism and precision

# **Redwood City Improvement Association**

We have just wrapped up our 10th year managing the day-to-operations of the Redwood City Improvement Association and it's been a very successful year for the organization including the debut of a community piano and partnering with the City of Redwood City on the upcoming Pedestrian Mall. This year, Chamber San Mateo County had 265 hours of Project Management hours. The Chamber is up for renewal on the management contract in January 2026, and the Community Benefit Improvement District expires December 2029.
