



Q2: What kind of business do you own, manage, or operate?








Q4: As of February 1, 2020, how many full-time employees did you have?



Q5: As of February 1, 2020, how many part-time employees did you have?




Q6: Have you eliminated any full-time and part-time positions since the COVID-19 restrictions were enacted in San Mateo County?





Q7: Of your remaining employees, have you had to reduce their work hours in the last few weeks?





Q8: Have you reduced your hours of operation since the COVID-19 restrictions were enacted in San Mateo County?





Q9: Has San Mateo County's Shelter in Place order closed your business completely or are you able to function remotely?





Q10: Does your business have online or e-commerce capabilities? Select all that apply.






